Fire = 8 - Fire, 1 - Vehicle, 1 - Cancelled in route, 1 - Water Rescue, 1 - Mutual Aid.

EMS = 18 - Lift Assist/Falls, 4- Trauma, 6 – Airway, 2- Stroke, 4 – Mental Health, 1 – Medical Alarm, 2 - Diabetic, 1 – Seizure, 1 – Cancelled in route, 24 – Other Non-Descriptive.

- In an effort to have a more accurate picture of the run volumes completed in 2022, we are in the process of auditing all the calls/runs made, but as of today: 1-11-2023 there have been a total of 695 calls that Station 4 responded to in 2022. The breakdown is 167 Fires and 528 EMS calls.
- c. MiOSHA/CET Report 14 items were written up as needing attention/correction. All items, except for 1 have now been corrected. A letter to has been sent with pictures to CET showing all our corrective actions.

As you can see from the data, lift assist and falls accounted for 182 of the 528 calls. Misc. calls include a variety of things including not feeling well, knee pain, dizziness, throwing up, unable to stand, etc..... This accounts for the highest number of call responses at 243. Public education will be critical in 2023 on public services in elderly assistance and when to call 911 and when and how to get a ride to the doctor/hospital including using Benzie Bus's non-emergency Transport Services.

In regards to Fire, the trend is going to be on reducing nuisance alarms, such as gas and smoke detectors. Vehicle accidents sadly will happen, but water accidents through public education can be prevented. Programs provided in the schools and to the general public can help reduce these types of calls.
