

Resolution #2025-004
Village of Elberta Water, Sewer, and Trash Cart Rates

The following resolution was offered by Trustee, Jennifer Wilkins, and supported by Trustee, Emily Votruba.

WHEREAS Chapter 2061 Section 14 of the Village of Elberta Code provides for an annual review of the Water and Sewer rates and charges along with recommendations for the rates and charges; and

WHEREAS the Village, with assistance from Fleis and Vandenbrink’s Capital Improvement Plan, the new Republic Services Contract, while strongly encouraged by EGLE to raise the rates in accordance with CIP suggestions, has completed their review of the Water System assets and rates for Fiscal Year 2025-2026; and

WHEREAS it has been determined that the Village Trash Cart Rate and Water and Sewer system charges do not generate sufficient revenue to cover the cost of operations, loans, maintenance, and repairs of the Water and Sewer systems, and trash cart contracted rates; and

WHEREAS Chapter 2061 Section 6C of the Village Code authorizes the Village Council to set rates and charges for the Water and Sewer Services.

BE IT RESOLVED that the March 1, 2025 (March usage billed beginning of April 2025) Water, Sewer, and Trash Carts Rates shall be as follows:


