Re: Frankfort Fire & Rescue Department Report for the Month of March/April 2024.

I. Administrative

- Fire Department
 - Membership There are currently 28 members on the roster and 3 Cadets.
 - Officers Meeting
 - 1. April 5, 2024
 - a. Reviewed draft preplans presented for both Graceland Fruits plants.
 - b. Reviewed the Special Land Use permit for "Camp Nearby" in Crystal Lake Township.
 - c. April's training plans Hydrant Operations at Crystal Downs
 - d. Business meeting topics for our April 9th meeting including an Agenda Outline for future meetings.
 - Business Meeting March 12, 2024 18 Attended.
 - 1. Monthly equipment/truck checks completed.
 - 2. Countywide Training Opportunities were presented along with our Training plans for March 26th.
 - 3. The National Park Service (NPS) provided the department with free National Parks and Federal Lands pass for the 2024 season. These were passed out to the membership.
 - 4. Med-Control meeting notes were shared from their March 12, 2024, Teams Meeting.

II. Training

- On March 26, 2024, we completed level of function training by creating stations on pump operations, water supply, hose, appliance, and nozzle deployment, ladders, ropes, and knots including tools hosting, Jaws equipment skills testing, and CPR/AED pad placement refresher on a mannequin. All these stations involved wearing an SCBA tank on their back. There were 13 in attendance.
- On Saturday, March 30, 2024, a Wildland/Urban Interface Refresher class was held at the station. There were 9 in attendance.

IV. Community Risk Reduction (CCR)

- As part of our ongoing CCR project on Smoke / CO detectors installations the following Detectors were installed as part of the MI-Prevention Program.
 - 11 Bed Shaker / Strobe Light Smoke Detectors were installed.
 - 8 Smoke detectors and 1 CO.
 - 1. These installations occurred in the City of Frankfort, Gilmore, and Crystal Lake Townships.
- On Monday, March 11, 2024, attended coffee with the residents of Michigan Shores and demonstrated the dangers of a 9v battery in a junk drawer and the bed shaker/strobe light and its benefits.

- The UTV was sent for service and needed new brakes on all four wheels, tie rod ends, spark plugs, and an oil change.
- The backflow preventer on the south wall was repaired on Wednesday, April 3, 2024.
- MiOSHA Part 451 Requirements
 - 1. All our SCBAs passed their annual flow testing.
 - A quarterly air sample was taken on the Air Machine and sent in. The
 results were received on Wednesday, April 3, 2024, and the breathing air
 passed inspection.
- Last month the Fleet ran a total of 707.9 Miles and used a total of 46.2 gallons of gasoline and 94.2 gallons of diesel.

X. Happy Notes:

On March 22nd, while installing bed shaker smoke detector alarms at Michigan Shores, the Frankfort Fire Department detected a potential health crisis. We were able to assess the patient and summon Benzie EMS Advance Life Support (ALS) unit to transport the patient for a Life-Threatening event.

On March 29th, the Frankfort Fire Department was called to the scene of a possible heart attack, with CPR "In-Progress". Station 4 Medical arrived within 3 minutes of the call and took over patient care from the bystanders. Benzie EMS arrived and assisted Station 4 EMT's. Before the patient was transported, they had regained ROSC (Return of Spontaneous Circulation). I'm proud to report that the Frankfort Fire Department did an outstanding job saving this person's life!
