I. Village of Elberta – March Calls

II. 2025-2026 / Fire & First Responder Contracts

- a. These are being presented to the City Council for approval on Monday, April 7th. Once approved, they will be distributed for countersignatures.

III. Frankfort Fire & Emergency Services responded to a total of 42 EMS Calls and 24 Fire Calls

- The average response time was 4 minutes for EMS and 9 minutes for Fire
- The average turnout for fire calls was 7 members.
- We averaged about 2.2 calls per day in March.

V. Equipment / Building

a. 4-Engine-3

- i. Tool mounting straps arrived, and the loose tools in the side compartment are now mounted.
- ii. We are currently working on mounting the attic ladder to the side of the truck.
 - 1. 4-Engine-2 is currently parked in the garage in Lake Township.

b. 4-Brush-2

- i. This truck is now parked at Frankfort. We are waiting for cost estimates on some needed repairs from Bayshore Tire and Auto.

c. 4-Brush-1

- i. This was put into service as a brush truck on Saturday, March 29th.

d. Self-Contained Breathing Apparatus (SCBA)

- i. MES came and conducted the annual flow testing on all the air packs and replaced the batteries.
- ii. In accordance with MiOSHA Part 451, a mandatory SCBA fit test was conducted for all the members on Tuesday, March 25th.

- e. We had a water pipe break under the concrete in the kitchen area on March 13th. This has since been repaired.
